

TERMS AND CONDITIONS OF DOG-FRIENDLY ACCOMMODATION

In response to feedback, Bellarine Bayside is conducting a three-year trial of dog-friendly accommodation options within our year-round holiday park at Portarlington.

By running a trial period restricted to the quieter times of the year and in a dedicated dog-friendly section of the park, we can explore the feasibility of welcoming dogs more broadly in the future, while continuing to comfortably accommodate people who choose to holiday with no dogs.

These Terms and Conditions form part of the Caravan Park Rules for Bellarine Bayside made pursuant to the *Residential Tenancies Act 1997 (Vic)*.

All users of the dog-friendly accommodation agree to the following Terms and Conditions:

- 1. Dogs are only be permitted to stay during the designated time periods listed on the Bellarine Bayside website: www.bellarinebayside.com.au/accommodation/dog-friendly-accommodation.
- 2. No more than two (2) dogs may be situated on a tourist site.
- 3. No more than one (1) dog per designated dog-friendly cabin.
- 4. All dogs must be registered with Bellarine Bayside with registration granted or denied at Bellarine Bayside's sole discretion.
- 5. Registration may be revoked by Bellarine Bayside at its sole discretion at any time.
- 6. All dogs must be healthy and free of parasites (e.g. worms and fleas).
- 7. All dogs must always be on a lead, no longer than three metres in length.
- 8. Dogs must not be left unattended on-site at any time, including inside a tent, caravan, cabin or other vehicle or accommodation.
- 9. Dog owners must not allow dogs to enter other sites.
- 10. Dogs are not allowed near (or inside) communal facilities, including amenity buildings, laundries, kitchens, BBQ areas, games room, playgrounds, beach pods or reception.
- 11. Dog owners must clean up after their dog immediately and dispose of waste by placing sealed bags into the rubbish bins.
- 12. Dog owners must keep dogs under control at all times. Excessive barking will not be tolerated.
- 13. Penalties apply for the injury or death of native wildlife. Any injury or death of wildlife is the full responsibility of the dog owner.
- 14. Dog owners are responsible for any personal injury and/or property damage or losses in relation to any actions by the dog.
- 15. After 6:00pm, dogs must be kept securely to prevent escape.
- 16. Any dog that has been declared dangerous, menacing or a restricted breed in Victoria must not be brought into the holiday park.
- 17. Park laundry facilities must not be used to wash pet bedding.
- 18. Additional charges may be applied to dog-friendly cabins if extra cleaning is required.
- 19. Your pet must not be walked around the holiday park but may be walked in a designated pet walking area where one is provided.
